

Content License Agreement

Image Usage

Purchasing product from Container and Packaging (Container) does not automatically grant you the right to use our images. When you purchase product from Container, you are purchasing the tangible product only; This transaction does not grant you the right to use our copyrighted product images.

To use our copyrighted images, you must:

- 1. Be a customer of Container;
- 2. Pay a nominal licensing and processing fee of \$50;
 - The \$50 fee includes web-ready images of the item. (This includes three different product views when available.) High res-images are also available, but will be subject to an incremental charge for file prep.)
- 3. Have a properly executed Content Licensing Agreement on file with Container (returning an executed signature page is sufficient);
- 4. Use only the images of products for which Container is your primary vendor.

Why we care?
